ELIGIBILITY

The Legal English course is designed for lawyers who are nonnative speakers of English attending the College of Law's LL.M. program. Students attending other LL.M. programs or with an interest in legal studies are welcome. A minimum TOEFL iBT of 90 is assumed for participants of Legal English.

Deadline for submitting the application:

- **60 days prior to the beginning of the semester** is the deadline for applicants who are **not currently in the U.S.**
- **30 days prior to the beginning of the semester** is the deadline for applicants **currently in the U.S.** on a valid visa (other than B1/B2 or F2).
- Please be advised, once the completed application is submitted it may take up to **5 working days to process.**
